Dear Parent/Guardian

Re: School Buses and Vehicular Access to School Site

In Belfast Model School for Girls we are very eager to develop and encourage a culture and a practice amongst our students of staying to work or play outside of school hours and to promote a fit and active lifestyle.

We want this to happen in a safe and secure environment. On a 'normal' school day staff will be on site to supervise students from 8.30am until 4.30pm in the evening.

Parents/guardians should be aware that no arrangements have been made to supervise students outside of these hours.

For special school events, parents/guardians will be notified of the arrangements and supervision will be organised by the staff in charge.

I also wish to take this opportunity to remind parents/guardians who use a car to drop off or collect students from school **NOT TO drive into the school site in the morning or in the afternoon when buses are coming to the school site.** ONLY **authorised visitors** may access the school site. Authorised visitors can park within the school site from 9.15am onwards. If you have an appointment before this time you will have to park outside the school gates. Apologies for any inconvenience this may cause.

ONLY school staff will have vehicular access to the school site before 9.15am.

AMEY staff will be present to ensure that there is no unauthorised parking within the school site.

Too many vehicles in such a limited space poses a real risk of an accident happening and the school buses cannot park safely so as to allow students to disembark or board. Please DO NOT park at any time in the bus lanes or in a manner to block Dunowen Gardens, as this creates mayhem for bus drivers, students and residents.

**Please note:** Parents requiring access to the site on the basis of medical grounds are advised to contact the school office so that arrangements can be put into place.

Finally, we have recently been in contact with management from Translink to make them aware of some issues students are presently experiencing with their service. I raised the following issues:

- In the morning buses along various routes are driving past students standing at a stop as the buses are too full
- In the morning buses are arriving late to pick up students so students are then late for school. I reminded Translink that all students using their bus service should be here on site no later than 8.45am

Thank you to all those parents who have let me know their concerns – I am lobbying on your behalf but please contact Translink directly and complain if needs be – this will only strengthen our case.
